1.1 Need and Importance of Income Tax

Many of you would have a question in your mind who has never worked before or never paid taxes and wonders that "do I also have to pay taxes? If so, how much? And most importantly, how?"

Let us begin by explaining why Government needs to collect tax. Government needs to collect tax so that it can spend on various items which benefit the country as a whole. For instance, if the government did not pay the salaries of Army men, who would? And if the Government did not build roads and put street lights in the cities, who would? There are many other expenses that the Government undertakes to ensure that the really poor people of the country are taken care of. And when we pay taxes, we help the Government to do all these things.

We have to pay income tax on the income that we earn between April of one year and the following March. This is called the financial year. Although the financial year ends in March every year, the Government gives us until the end of July to file our returns (i.e. fill in a form telling the Government how much we have earned from various sources) and pay our taxes.

Over centuries, Governments have tried different forms of taxing people. Today, the most popular way of taxing people by Governments across the world is progressive taxation. This means that rich people are taxed more than poor people. For instance, our government does not expect those whose salary is less than Rs.2,50,000 per year to pay tax.

Now let us understand what the benefits are and why should we file:

A lot of individuals seem to think that filing tax returns is voluntary and therefore dismiss it as unnecessary and burdensome. As we will see, this is not a very healthy perspective on tax-filing.

Filing tax returns is an annual activity seen as a moral and social duty of every responsible citizen of the country. It is the basis for the government to determine the amount and means of expenditure of the citizens and provides a platform for the assessee to claim refund, among other forms of relief from time to time.

- Filing tax return is a sign that we are responsible and it also makes easier for individuals to get loan and credit card as the financial institutions such as Banks ask for copies of return before they give loan.
- If your TDS has been deducted and if you do not file returns and your income is below taxable limits, you shall not be able to claim the refund. Hence, it becomes easy to claim refund if you file your returns
- If someone wants to bid for Government contracts, Government also verifies the financial background and if returns are filed on time, it can be easier to secure the tenders.
- Non filing of returns also attracts penalty and hence it's beneficial to file returns to save one from penalties.

There are many more benefits of filing Income Tax returns and these are few of the main benefits.
